#### **Fees**

There are no entrance fees to visit Dane County Park properties, however some activities require a reservation or a permit.

We offer "Senior" and "Disabled, Military, and Veteran" reduced fee permits for several activity permits, including Dog, Lake Access, Horse and Mountain Bike permits. We also offer financial assistance to Dane County residents with financial limitations that prevent them from purchasing a permit.

# Jenni & Kyle Preserve

The Jenni & Kyle Preserve is a fullyaccessible county park intended to serve children younger than 14 and persons with disabilities and provides accessible fishing and picnic areas, trails, wheelchair swings and a shelter building around two springfed ponds containing trout and panfish.

# **Equestrian Trails**

Equestrians have access to more than 26 miles of trails in five different parks, each with its own unique features and terrain.
